Please Note:

All new Connections will incur a Network Contribution Charge (NCC). This will be provide on application and may range between \$1,500 and \$7,500 depending on location

Upgrades will be assessed on an as and when basis and an appropriate charge applied.

Late payment fee will apply to all accounts not paid by the due date.

A further overdue penalty charge WILL apply to overdue accounts not paid in full by the 10th of the month following the date the account was due for payment.

Interest will be automatically charged on all overdue monies (including late payment and penalty charges) effective from the 10th of the month following the date the account was due for payment.

DISCOUNT

All New Customers will be entitled to a discount of 5%, ONLY if the account is paid in full on or before the discount date shown on your monthly invoice.

Customers paying by Direct Debit will receive a further 2.5% discount.

Notes:

1. A unit is a kilowatt hour (kWh).
2. A kVA is an assessment of the capacity provided to the customer.
3. Total Line Charges include the following: Fixed Distribution Charge and Variable Distribution Unit Charges
4. We require a security of payment (bond) for all new customers which is the greater of 3 months estimated usage or \$450.
