









CORRUGATED ROOFING MAXSAFE® MS02 ANCHOR INSTALLATION DETAIL FOR TIMBER FRAMING




6 RIB ROOFING MAXSAFE® MS02 ANCHOR INSTALLATION DETAIL FOR STEEL PURLINS

MS02 ANCHOR

FALL DISTANCE CALCULATORS

These charts show the allowable working zones required to reduce the risk of swing falls and improper side loading. ALWAYS adhere to the information specified. For example, if the anchorage connection is 1.8m from the leading edge (Y), the working distance (X) is 2.4m in each direction from the perpendicular, which translates to a 53° working angle.




DIAGRAM C. EXAMPLE OF SAFE WORKING METHOD PLAN





DIAGRAM B. EXAMPLE OF SAFE WORKING METHOD.

Personal Fall Arrest

MAXSAFE® MS02 ANCHOR may be used to support a maximum of a Two (2) Person Fall Arrest System (PFAS). Rated to 21kN. Maximum free fall is 1.8m, or up to 3.7m if used in combination with equipment explicitly certified for such use. Applicable D-ring: Dorsal.



Personal Fall Restraint / Total Restraint

MAXSAFE® MS02 ANCHOR may be used to support a maximum of Two (2) Persons in Fall Restraint/Total Restraint application. Rated to 21kN. Fall Restraint systems totally prevent users from reaching the leading edge of a fall hazard. Always account for the fully deployed length of the lanyard. No free fall is permitted. Applicable D-rings: Dorsal, Chest.



Work Positioning

MAXSAFE® MS02 ANCHOR may be used in Work Positioning applications. Work Positioning systems allow a user to be supported while in suspension and in position and have the ability to work freely with both hands and prevent the user from reaching the fall hazard. The system used should not allow a fall of more than 600mm. Applicable D-rings: Side, Chest, Dorsal.



Rescue/Confined Space

MAXSAFE® MSO2 ANCHOR may be used in Rescue/Confined Space applications. Rescue systems function to safely recover a worker from a confined location or after exposure to a fall event. There are various configurations of rescue systems depending on the type of rescue. Rated to 21kN. No free fall is permitted. Applicable D-rings: Dorsal, Chest, Shoulder.

THE MAXSAFE® MS02 ANCHOR IS RATED TO 21kN IF USED IN COMBINATION WITH EQUIPMENT EXPLICITLY CERTIFIED FOR SUCH USE.

Maintenance and Cleaning

Maintenance or repairs to a **MAXSAFE® MS02 ANCHOR** can only be made by an authorised MAXSAFE® representative. Contact MAXSAFE® for all maintenance and repair needs at: sales@maxsafe.co.nz.

Proper care is important for maintaining the safety and longevity of a MAXSAFE® MS02 ANCHOR. Remove all dirt, corrosives, and contaminants from any MAXSAFE® MS02 ANCHOR before and after each use. If MAXSAFE® MS02 ANCHOR cannot be cleaned with plain water, use mild soap and water, then rinse and wipe dry. NEVER clean MAXSAFE® MS02 ANCHOR with corrosive substances.

Inspection

Prior to each use all MAXSAFE® MS02 ANCHORS must be inspected by the user for anything that may compromise their safety. A MAXSAFE® approved person, other than the user, must complete a formal inspection annually, or more frequently if required, by the users safety management system. After each inspection the Inspection Log must be updated by the MAXSAFE® approved person with their initials and the date of the inspection. Separate and specific inspection logs must be used for each MAXSAFE® MS02 ANCHOR. All inspection records must be made visible and available to all users at all times.
