We held our crossover service at Showers of Blessings. We had a poor turnout because of the rains. Streams were flooded.

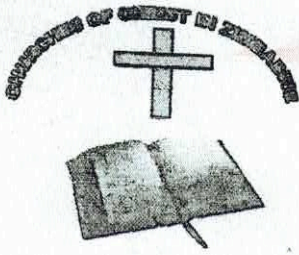
