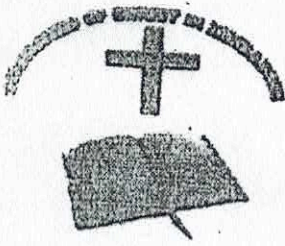


We had our leadership workshop at Siboa we would also have our own sermons at circuit level.
