### **REWAREWA STREAM - NEW LYNN CULVERT UPDATE**

Works are progressing very well on the culvert under Great North Road in New Lynn following the significant flood event in March 2017.

Healthy Waters/Auckland Council have taken the opportunity to not only repair and upgrade the culvert, but will also enhance the whole area including:

- A new public park over the new high-capacity culvert
- Further walking and cycling connections
- Infrastructure to enhance water quality

The original culvert has now been structurally strengthened and provided with an enlarged inlet to increase its capacity. This refurbished culvert will stay in service long-term to be the low flow conduit and provide passage for freshwater life. This original culvert will also ensure that there is a low risk of repeating any road damage during the installation of the new culvert. The new high-capacity culvert is a rectangular shaped four-metre wide x 2.75 metre high structure that is 65 metres long and is currently being constructed by excavating the road while maintaining traffic in both directions.

#### Amenities

On completion of construction, plans are underway to create an open space pocket park for New Lynn. The new pocket park will be located over the new high capacity culvert outlet. This open space will allow for seating and a small play area to be provided within a landscaped environment where people can enjoy the view of New Lynn's Rewarewa Creek.

Renowned designers Kobus Mentz, as well as Boffa Miskell, have been commissioned to lead the Rewarewa Stream redevelopment and to look at further cycling and walking connection opportunities that may be able to make the Rewarewa stream environment more accessible as a recreational amenity.

Significant water quality improvements have been incorporated in the new work as well. Heavily trafficked roads can be significant sources of contaminants. So, a new stormwater treatment system has been designed to remove these contaminants from the road run-off and installed underground alongside the culvert. This will improve the stormwater water quality from over half a kilometre of Great North Road and the busy Titirangi Road intersection before it discharges into the Rewarewa Creek.

The entire project cost is expected to be in the vicinity of \$15 million

The work on Great North Rd expected to finish early in the new year, that is weather dependent but the aim is for late February early March 2018.

# UMMUNICATIONS WITH THE COMM

On 12 April, 90 businesses and members of the New Lynn Business Association attended a meeting we held at the New Lynn RSA for the business community to provide them with as much information as we could. It was very well attended and we received positive feedback for holding it.

- We send regular email updates to 998 stakeholders including businesses in the area
- New Lynn Business Association is a BID or business improvement district - which means the local businesses in the area are part of the business association. We have been working very closely with the business association to provide timely updates about progress which they then share with their members
- A project working group has been formed. We have regular meetings to discuss the project and work progress - membership of the working group includes:
  - New Lynn Business Association
  - Whau Local Board
  - Auckland Council's Healthy Waters Department
  - Auckland Transport
- Contractors both designers and engineers

#### ADDITIONAL INFORMATION REGARDING THE PROJECT The current project is in two parts:

- 1. Construction of the culvert and related restoration of Great North Rd following the floods. This is on track for completion, as planned, by the end of February 2018.

2. At the same time, it has been decided to take the opportunity to bring forward upgrades of the area. These include opening the stream and its banks to public access, more planted areas, a new shared cycle and pedestrian path on the north side of Great North Road, some road layout improvements and footpath upgrades on the south side of Great North Rd, between the culvert and midway of the Bunnings road frontage.

A significant portion of this work is also expected to be completed early next year with the final completion expected by mid-May or earlier, however, it is most unlikely that physical works affecting businesses will take this long.

An exact timeline hasn't yet been developed for the upgrades and this will be finalised after further discussions with affected local businesses and property owners, with a view to completing works with the minimum possible disruption to business/property. Businesses and property owners have been contacted by Auckland Transport, asking them to share their concerns so that these can be taken into account.

For construction and financial efficiency, it is planned to retain the contractor already established on the site for the culvert works, to also undertake the upgrades.

These works are in accordance with a design agreed by a working party established after the floods to restore and generally upgrade the area. The working party comprised members of the Whau Local Board, New Lynn business and officers of Auckland Transport and Auckland Council's Healthy Waters division. The design was adopted last month by the Whau Local Board.

### NLBA EXECUTIVE MEMBERS

Each year at the AGM, members vote for a new committee. We would like to take this opportunity to thank new members and those members who have worked voluntarily in the past.
