In this edition, you will see that the popular Grab-A-Deal promotion is soon




to take place. This has always been an incredibly popular promotion with both the membership and our shoppers. We look forward to implementing this promotion and supporting our membership. **Thank you,**

NLBA Covid-19 membership survey results


Purpose: Member and associate research project to identify member opinion, level of interest, participation and considerations to the current situation and considered future of the NLBA business



The findings of the NLBA Covid-19 survey provide information which give opportunity to the New Lynn Business Association Executive Committee to be supported to implement good governance practices and sound, evidence backed decision making. To support the membership in a way that is evidence based and provides for sustainable decision making.


Some of the feedback is provided below. The information is to be read in conjunction with the economic situation and with consideration to the 32 survey question responses.


- Recovery for some businesses will take a long-time (years) to be in the same position that they were in prior to the pandemic.
- There has been an impact on the New Lynn BID membership because of Covid-19 by varying degrees. This is due to lockdowns and alert level changes. Despite this, the findings of the survey indicate the membership are resilient and through the significant uptake of subsidies (graphs 18, 18.A and 20), they have continued to be positive and to work through the challenges.
- The unemployment rate has not been as high as initially expected when the pandemic began. The current data shows Auckland unemployment at 5.3% and NZ at 4.7%, the expectation was that the level would be much higher and that would have a greater economic impact.
- At Level 3, there are approximately 200 jobs lost per day and this has an impact on consumer spending.
- The local housing market: We have identified that the Crown Lynn Yards development continues and approximately 3,000 homes will, in time, be located on this site. Local residential housing growth continues at a rapid pace. This will result in an expanded consumer base.
- There are limited sectors/industries affected by the pandemic. Those are mainly border related, tourism and some impacts on building however, consenting is at the highest level ever in the history of Auckland Council. This had an impact on the travel sector in New Lynn.
- Of all respondents, 67% indicated that Covid-19 had a profound (negative) effect on their business and 20% indicated up to a small (negative) effect on the business. This finding indicates that 87% of respondents had either a negative profound or small negative effect on their business.
- Question 7 talks about turnover and profit, the results indicated that there was a substantial decrease in profit and turnover 35% of respondents said they had a decrease of 20%-50% and 25% of the respondents said they had up to 25%. 15% of respondents shared they experienced more than a 50% decrease in profit and turnover. Whilst this was for the period of a month, the question was to compare to normal expectations for this time of year (that is not in a COVID-period). This is an important finding as it clearly indicates the significant impact on the local business community.
- Question 26 referred to respondent's opinion on the impact of a further lockdown. 32% of respondents said that they would experience Emotional Harm, 21% of respondents said they would not financially survive and 4% indicated they would cease trading. This result indicates the importance of a budget that supports businesspeople and post Covid-19 actions.

















Community Organisations
