We were pleased to hear of the announcement from Kiwi Income Property that the LynnMall redevelopment at \$36million is proceeding, works have started and by late November we hope to see the completion of the redevelopment. Plans for the development include an 8 plex Redding cinema with a dining precinct named "Brickworks" also the new Bunnings on Titirangi/Great North Road will open early this year, another good new business for New Lynn.

However, Auckland Council staff are still looking at ways to charge BID's a service fee. We will continue to object to any fees from Auckland Council.

The New Lynn Business Association committee are a group of elected voluntary business people who dedicate time and energy to supporting our economic, social and cultural growth. I would like to acknowledge past and present members of the New Lynn executive and thank them for their time. This year the NLBA AGM saw 15 nominations for the executive committee. This is a show of support from the business community for our organisation. As a team we rolled out with much success the 2014 marketing and business plans, tried new activities, got involved in new projects and worked toward our goal of achieving a thriving metropolis in New Lynn. We developed the Food Fiesta promotion which was a success, shared more information on social media and had a fantastic Christmas event, New Lynn looked great with all the Christmas decorations; our thanks go to The Trust Community Foundation for their ongoing support and the \$21,350 towards our Christmas activities. A group of Chinese elders who have settled in West Auckland found themselves owing this country a debt of gratitude, while enjoying the peace and beauty here. In July 2012, they decided to collect litter from street side in and around New Lynn and Henderson to help the urban environment look more beautiful, so did they.

Derek Battersby, the former chair person of Whau Local Board noticed their activities and connected them with Karen Summerhays, Auckland Council Environmental Programmes Advisor, and Huw Hill-Male, coordinator from council Local and Sports Parks West. Since then, the group formed into Auckland Environmental Protection Association (AEPA).

In late 2012, AEPA was granted \$7000 from Whau Local Board for their proposal on turning this small vacant corner of the of New Lynn Community Centre car park into a community garden. With facilitation and technical advices from Gardens4Health team of Diabetes Projects Trust, the project was started in March 2013, garden up and growing since September 2013. Over the past year, the garden was thriving, featured out a beautiful and productive space that attracted and amused many of community members and visitors.


