Notes to the Financial Statements

1. STATEMENT OF ACCOUNTING POLICIES

NZ Register of Holistic Aromatherapist Inc is an incorporated under its own constitution. These financial statements are special purpose financial statements and have been prepared in accordance with cash accounting.

These financial statements are prepared for members of the New Zealand Register of Holistic Aromatherapists Inc and may not be suitable for any other purpose.

The measurement base adopted is that of historical cost. Cash accounting is used to recognize expenses and revenues when they are paid or received.

(a) Changes in Accounting Policies

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in previous years.

(b) Fixed Assets & Depeciation

All fixed assets are recorded at cost or valuation less accumulated depreciation. Depreciation of the assets has been calculated at the maximum rates permitted by the Income Tax Act 1994. The rates used are shown on the schedule of fixed assets and depreciation attached.

(c) Goods & Services Tax

These financial statements have been prepared inclusive of GST as New Zealand Register of Holistic Aromatherapist Inc is not registered for GST.

(d) Income Tax

NZ Register of Holistic Aromatherapist Inc is a non-profit organisation, in terms of DV8 of the Income Tax Act 2007.
