This Community Emergency Preparedness Plan is a living document created by and for the [TASMAN AREA] community.




### Its purpose is to:

- Promote problem solving and encourage our community to be self-sufficient through strong social networks and a culture of mutual help.
- > Reduce the reliance on first responder agencies.

Because when emergencies happen, our community may need to be self-sufficient for several days.

## **About our community**

Widespread rural coastal community. Ridges & broad valleys landscape with Moutere Inlet sheltered by Kina Peninsula.

Small urban area in Tasman village, otherwise low density rural properties & productive agricultural land. Approx. 550 households (1250 - 1500 people) & steadily increasing.

Coastal cliffs but easy access to Tasman Bay & Moutere Inlet shoreline at several points.

Tasman Taste Trail encourages frequent cycling & walking.

Most workers commute to Motueka, Richmond/Nelson & Mapua.

Many residents are retirees & self-employed workers. Tasman village has 2 schools with a combined roll of about 200 primary age students.

Our area is defined mainly by stream catchments feeding the Aporo/Tasman stream & Moutere Inlet.

FIRE	Destruction of housing & businesses. Roads closed. Personal injury.	Fast spreading. Isolated properties. People cut off from family & escape routes. Need to assist people with mobility	Minimise trees close to property. Clean gutters. Rapid warnings. Comply with district fire status updates. Refer to page 9 for website
STREAM FLOODING	Damage to properties, roads, infrastructure. Blocked roads due to slips as well as floods. Isolation.	Access to cut off people & properties. Impassable bridges. Isolated family members.	Clear drains. Regular stream monitoring. Notify TDC about obstructions. Check weather forecasts frequently.
TSUNAMI	Infrastructure, roads & property damage. Massive debris piles blocking roads. Potential for loss of life or injury. Power outages. Potential damage to CD Centre from large Tsunami.	Low lying land & housing in Tasman village. Separated families. Damage to roads by or close to the coast e.g. SH60 to Motueka, Aporo & Kina Peninsula roads.	Awareness of exposed areas. Assess how to help vulnerable people Rapid communication. Have escape plan to high ground.
EARTHQUAKE	Potential for serious to catastrophic damage to property/infrastructure. Widespread damage to numerous structures. Potential for injury & loss of life.	No to little warning. Impassable roads due to slips/land distortion: even flooding. Perhaps many days of isolation & failed infrastructure. Separated families. Possible damage to CD Centre.	Emergency kit & family escape/rendezvous Plan. Awareness of CD Centre & alternative meeting/shelter points. Ability to aid vulnerable people.

STORM/ TORNADO	Infrastructure, roads & property damage. Flooding, downed trees. Potential for loss of life or injury.	Perhaps little to no warning. Separated families. Blocked or damaged roads. Housing destroyed.	Communication. Risk awareness. No trees that could fall on house. Escape or shelter plan & emergency kit.
PANDEMIC	Widespread illness. Isolation. Potential death at home.	Risk of additional infection. Inability to re-stock household supplies. Access to medical care. How to aid vulnerable people.	Good hygiene.  Current vaccinations.  Food & water for several days in emergency kit
LANDSLIPS	Low risk but possible. Blocked roads. Stream flooding. Property damage. Potential for injury or worse.	Isolation & access.  Requirement for earthmoving equipment & land stabilisation.	Awareness of potential risk points/areas.  Inform TDC about potential risk sites.

# **Potential gathering places**

If you can't stay home or with family and friends or are searching for each other these are possible gathering places or Community Led Centres.

Hazard type	Potential gathering places	Facilities for animals
FIRE & TORNADO	Tasman Church / Community CD Centre, corner of Aporo & Williams Roads.	Some fenced land at church but only suitable for dogs etc.: not stock. Option for stock on plenty of fenced land nearby Tasman church & elsewhere.
STREAM FLOODING	Tasman Church / Community CD Centre, corner of Aporo & Williams Roads.	As above & consult survey response info.
TSUNAMI	Tasman Church / Community CD Centre unless large tsunami predicted. Tasman Motor Camp can be a safe temporary alternative.	As above.
EARTHQUAKE	Tasman Church / Community CD Centre unless large Tsunami is predicted.	As above.
